Claremore Invitational Meet

June 13, 2015

- Location:** Claremore Super Recreation Center, 595 Veterans Parkway, Claremore, OK 74017, 918-341-4516. (Some map web pages find it at 595 S. Boling St.)
- Facility:** Six lane, 25 yard pool
- Times:** The meet will begin at 9:00 a.m. Warm ups will begin at 7:00 a.m. with times assigned by the Meet Director. The officials meeting will be at 8:30 a.m. The coaches meeting will be at 8:45 a.m. Lane timing and place judging will be assigned by the Meet Director in proportion to each team's participation.
- Meet type:** Timed finals.
- Entry deadline:** Entries in the form of a HY-Tek or Team Unify entry file and a report of the entries must be received by 2:00 p.m. on Tuesday, June 9, 2015. Entries should be emailed to Charles Haverstick at cfhaverstick@bteswim.com
- Entry Limit:** Each swimmer can swim a maximum of three (3) individual events and two (2) relays.
- Entry fees:** \$2.00 for each individual event
\$5.00 for each relay
Deck entries are allowed at \$4.00 for individuals and \$10.00 per relay.
Scratches should be submitted by 8:30 a.m. on the day of the meet. Scratches received before we print the heat sheet will not be charged.
Checks should be made payable to: Claremore Swim Team.
- Awards:** Ribbons will be awarded for 1st-6th place for individual events.
Relay event ribbons will be awarded for 1st-6th place.
Team trophies will be awarded for 1st-3rd place in A division and for the most Improved team in the B Division.
Age group individual high point awards for both men and women will be awarded.
Best time and heat winner iron-ons will be given.
- Scoring :** Scoring will be standard scoring for a 6 lane meet as defined in USA Swimming rules: 7 points for first place, 5 for second, 4 for third, 3 for fourth, 2 for fifth, 1 for sixth. Relays will be double the points for each place. The B division trophy will be awarded to teams with 10 or greater

participants, or 20% of the team's total registered swimmers as of June 13, based upon highest percent improvement as calculated by the HyTek Meet Manager software.

Heat Sheet: Heat sheets will be available to buy at the meet. If you would like to place ads in the heat sheet, please contact us for prices.

Rules: Tri State Swim Conference rules and rules adopted by the conference from USA swimming will be followed.

Officials: Officials will be appointed by the host team. Anyone willing to help officiate should contact the conference head official, Bob Cummins, and attend the officials meeting before the start of the meet.
